59th Annual Show Rules (2022)
BEXAR COUNTY JUNIOR LIVESTOCK SHOW
General Rules

It is the exhibitors' responsibility to familiarize themselves with all the General Rules and Regulations of the Show and other rules in the classes and departments applicable to their exhibits.

1. **AUTHORITY** - Final and absolute right is vested in the Executive Committee to interpret these rules and regulations and to arbitrarily settle and determine all matters, questions and differences in regard thereto, or otherwise arising out of or connected with the show. Executive Board has option to change show schedule [for the good of the show](#).
2. **LIABILITY** - All exhibits will be under the control and direction of the Executive Committee. Each exhibitor will be solely responsible for any consequential or other loss, injury, or damage done to, or occasioned by, or arising from any animal or article exhibited by him or her. He or she shall indemnify difference in regard thereto or otherwise arising out of or connected with the show against all legal or other proceedings in regard thereto, as well as damages or injury to any other person or out of, or in any way connected with such exhibition or any animals so exhibited. All cattle exhibited must be broken to halter.
3. **UNRULY ANIMALS** - Any unruly animal will be removed from the show by request of the Department Superintendent and the Show Superintendent.
4. **APPLICATION FOR ENTRY** - All applications for entries must be made on printed forms which may be obtained from the County Extension Agents Office or any Agriculture Science Teacher or on the BCJLS web site (www.bcjls.com). These forms must be filled out completely, signed by the exhibitor, and turned into the Club Manager or Agriculture Science Teacher for signature. The AST or Club Manager must enter all show entries into the Online ShowWorks portal no later than midnight November 1. **The AST or Club Manager must submit hard copies of the entries and payment to the Bexar County Junior Livestock Show Secretary on or before November 15th.** Hard Copy entries received or postmarked after that day MAY be rejected at the discretion of the Show Officials. Late entries for non-market or breeding projects will be double the fees and will only be accepted on the day of show.

For market animals only, late entries will be accepted the day of the Show at a cost of \$100 per entry. Late entries will be accepted with cash, cashier check, money order or credit card only.

5. **ENTRY FEES**-There will be no refunds of fees.

6. WHO MAY COMPETE - To be eligible for the Bexar County Junior Livestock Show, students must be eight (8) years old on or before September 1 of the current livestock show year, and have entered the third (3rd) grade. All market show, creative arts, or ag mechanics exhibitors must be a Bexar County 4-H Member, FFA or Junior FFA member and must be enrolled and regularly attending a public or private elementary or secondary school of a Bexar County school district or be a permanent resident of Bexar County during the time of the Bexar County Junior Livestock Show and have continuously, personally fed and cared for their animals under the supervision of a 4-H Club Manager or Agriculture Science Teacher throughout the entire required feeding period. No boy or girl who has graduated from high school will be eligible to exhibit in this show. No boy or girl will be eligible to show in the Bexar County Junior Livestock Show if they sell in any other of the surrounding county shows, where school districts overlap into adjoining counties that hold an auction sale within the same calendar year, with the exception of the major shows. Breeding shows may be open to FFA or 4-H members from any of the seven Counties that are adjoin Bexar County – Bandera, Kendall, Comal, Guadalupe, Wilson, Atascosa, & Medina.

7. CERTIFICATION OF ELIGIBILITY - Those wishing to exhibit in the Bexar County Junior Livestock show must have a 4H Club Manager or Agriculture Science Teacher, under whose supervision the animal was fed, certify on the entry form that the animal was fed and conditioned by the exhibitor. THE CEA or AST must notify the BCJLS Secretary of any Exhibitors suspended under Texas Education Code 33.081 "No Pass, No Play" during any portion of the Bexar County Stock show or Auction that are ineligible to participate in any Bexar County Junior Livestock Show activity, event, or competition in accordance with applicable State Law. Any animal owned by an ineligible exhibitor is ineligible for competition.

8. NUMBERS OF ENTRIES - Exhibitors in market classes are limited to the exhibit of three (3) market animal units per division with a maximum of two (2) market animal units in any market poultry class. An animal unit shall consist of one of any animal or one pen of rabbits or broilers.

9. SIFTING - A sifting committee, appointed by the Board of Directors, will pass on all animals entered in the Bexar County Junior Livestock Show. Sifted animals will not be allowed to compete for prizes and must be removed by the owner from the show grounds immediately after sifting. All steers, lambs, goats and swine will be State or County Validated. Any animal that does not meet State or County Validation information will be disqualified from show. The decision of the sifting judge is final.

10. UNETHICAL FITTING - The showing of unethically fitted livestock in the Bexar County Junior Livestock Show is prohibited and will be sifted. Unethical fitting will be deemed to consist of any method of altering the natural conformation of any part of the animal's body evidenced by the presence of abnormal tissue or foreign substance. To prevent any confusion, the removal of ties and surgical dehorning is permissible. The use of chemicals not approved for market show animals (steers, lambs, swine, poultry and rabbits) to be used for human consumption shall not be tolerated. Undetermined withdrawal times and safety data of tranquilizers are reasons unapproved drugs shall not be used in food animals. Drug residues are human health hazards. The use of drugs and chemicals in show animals with intent to deceive relative to the animal's soundness, conformation, body weight and disposition shall not be tolerated. Use of drugs such as steroids, tranquilizers and diuretics are unethical. The use of drugs, chemicals and medications, including medicated feed approved for market show animals (steers,

lambs, swine, poultry and rabbits) to be used for human consumption shall not be administered within the withdrawal times prior to show. Drug residues of dewormers, insecticides, antibiotics and antibacterials are human health hazards. Abuse or misuse of drugs and chemicals in show animals by an exhibitor will result in his or her being disqualified from the Show and will result in forfeiture of all premiums and prize money. The exhibitor of any animal in any division agrees to submit their animal, entered by him/her to inspection by a veterinarian appointed by the Executive Committee and agrees to have such animal submitted to such tests as may be requested at any time. BCJLS reserves the right to have D.N.A., blood and/or urine laboratory analysis made on any champion or reserve champion. The exhibitor, including parent/guardian, AST or CEA and superintendent of division must be present during the collection for testing and must witness, seal and sign the sample, thus verifying the sample to be properly collected and prepared for analysis. The conclusion reached by the veterinarian and analysis shall be final and conclusive without recourse against BCJLS. The exhibitor waives any right of action which he /she might have for any action taken under this rule, and releases BCJLS and the veterinarian from any and all claims or demands whatsoever in connection with the inspection or testing. In the event any animal is declared by the veterinarian or testing agency to be unethically fitted, the Executive Committee is authorized to permanently bar the exhibitor and his/her family from any further participation in the BCJLS. The exhibitor will also forfeit all titles, awards, prizes and auction proceeds.

11. FEEDING AND BEDDING - All exhibitors must furnish all feed and bedding for their animals. Bedding will comply with the San Antonio Livestock Show Ground Superintendent's ruling for allowable bedding for that year.

12. JUDGING - Two judges will be used for this show with one judging the animals and a separate judge to judge showmanship, except where the Board of Directors has determined to use only a single judge. The decision of the judge is final in all cases. County Extension Agents and Agriculture Science Teachers may not enter the judging or sifting rings while judging or sifting is being conducted. No adult may assist in the fitting of an animal while it is in the show ring, only its exhibitor may groom or care for it while it is in the show ring, while the judge is judging.

Judges will be determined by the Board of Directors. The Board will take into consideration recommendations from the AST, CEA and superintendents. Judges names will be posted on the website by August 31st, or as soon as confirmed. The names are subject to change by the Board as deemed necessary.

13. PROTESTS - All protests must be in writing and accompanied by a cash deposit of \$100.00 which will be forfeited if the protest is not sustained. Such protests must state plainly the cause of the complaint or appeal and must be made within one (1) hour after the show is over (i.e., steer show, lamb show, poultry show etc.).

14. WEIGH-IN -All animals will be weighed in according to show schedule. Designated official digital scales will be used for the official weigh-in and will be controlled by the Show Superintendent. The Show Superintendent will act as the official weigher, or he will appoint some

responsible person to assume that duty. Any exhibitor may bring the animal to the scale for the weigh-in. There will be one official weigh-in with no reweigh at a later time. If a parent, leader or a Agriculture Science Teacher has any questions concerning the weight of an animal, have animal removed from the scale, check the balance of the scale, and then recheck the animal's weight. The animal being rechecked will exit the scale and reenter the scale immediately for the recheck. The animal being rechecked cannot leave the scale area.

15. CLASSIFYING - Steers, lambs and swine will be classified at weigh-in. The exhibitor will declare the breed of the animal as the animal crosses the scales. The classifier will either accept the exhibitor's declaration or will move the animal to the appropriate class. The decision of the classifier is final and not subject to appeal. Any individual that disputes and/or argues the classification of an animal is subject to having their animal, or their child's animal(s) disqualified from the BCJLS.

16. OWNERSHIP PERIOD - All animals must be owned and continuously cared for by the exhibitor for the following periods:

- Market/Breeding Beef - by the Texas Beef Validation deadline
- Market/Breeding Swine - by the Texas Swine Validation deadline
- Market Sheep - by the Texas Lamb Validation deadline
- Market/Breeding Goats - by Texas Goat Validation deadline
- Market Poultry - by BCJLS Validation deadline
- Market/Breeding Rabbits - by BCJLS Validation deadline BCJLS Validation deadline:
- Poultry - Date Broiler/Turkeys are distributed
- Rabbits - Date of last Rabbit validation event.

All Market Show Validation information shall be submitted to the BCJLS Show Secretary no later than 5 days after the Validation deadline.

Only a county tag will be used on those animals (hogs, lambs and goats) not planning to show at major shows.

17. ALL entries in the BCJLS must be shown by their owner.

- a) Exhibitor substitutions will be allowed if the exhibitor has more than one entry in a class or the exhibitor has entries in more than one show, which is showing at the same time. Such substitutions should be requested by the parent and/or Club Manager or Agricultural Science Teacher notifying the Division Superintendent prior to the judging of the animal.
- b) Exhibitor substitutions may also be allowed in the case of sickness or injury with a letter from a medical provider to the Division Superintendent for approval prior to the judging of the animal.
- c) If the exhibitor is unable to exhibit their animal due to any other reason not mentioned in 17. a or b, the Division Superintendent must be notified by the exhibitor's parent and/or

Club Manager or Agricultural Science Teacher. Approval by the Division Superintendent of a substitution will be required by submitting the BCJLS Exhibitor Substitution Form to the Division Superintendent prior to the judging of the animal. The BCJLS Substitution Form can be obtained in the Show Office.

- d) Any substitutions must meet the qualifications of General Rule No. 6 (Who May Compete)

18. **PARTNERSHIPS** - Animals owned by FFA Chapters or 4-H Clubs will not be eligible to show.

19. **HEALTH REGULATIONS** - The current rules and regulations governing admission of livestock to shows, fairs and exhibitions set forth by the Texas Animal Health Commission, 1020 Sam Houston State Office Building, Austin, Texas 78701, shall apply. These rules may be found in any major livestock show catalog.

20. **AWARDS** - This will be an award and premium show with an auction sale; method of placing to be determined by the Board of Directors. No premium money will be paid to market animals. The judge may choose not to award any placing ribbon as he deems appropriate for the class.

Breeding Animal Entries - Minimum number in Class do not apply for all Breeding Animal Classes. Remove Minimums in Breeding Beef (Rule 3b) AND Boar Goat (Rule 1). Premiums will not be awarded until at least 3 animals are in a class. Premiums for ALL BREEDING CLASSES will be awarded based on the Table Below.

Buckles will be awarded as listed below. Showmanship buckles in all divisions will be awarded to the winner in the junior showmanship class and to the senior showman in the senior showmanship class. There must be ten (10) entries or more in any division before two buckles will be awarded. If there are less than ten (10) entries then only one buckle will be awarded.

- Junior and Senior Showmanship Steers

Awards will be based on entries turned in November 1st- Entry Deadline. All premiums will be paid during the show. Premiums will be handed out with the ribbons. All premiums not picked up at the show (within 30 minutes) will be forfeited.

21. **GRAND AND RESERVE GRAND CHAMPIONS** - Second place winners in the class that the Grand Champion came from, will also compete for Reserve Grand Champion. All breeding classes will have a Champion and Reserve Champion for each breed. Rabbit breeding divisions and Breeding Beef, Breeding Swine, and Boer Goats.

22. **SHOWMANSHIP** - A showmanship award will be given to the outstanding Junior and Senior Showman in each specie division, except Poultry at the completion of the last class in that division. Rosettes will be awarded to the top Junior (8 - 13 years) and Senior (14 years old and over) in Beef Cattle, Swine, Goats, Sheep and Rabbit Divisions. All ages are figured as of September 1st of the show year. All finalists will receive a ribbon. An exhibitor must have an animal entered in that show (division) to be eligible to compete in the showmanship contest.

23. **RELEASE** - To be determined by show superintendent as to not disrupt the show.

24. **LIVESTOCK JUDGING CONTEST** - The Bexar County Junior Livestock Show reserves the right to use any animal to create classes for the Livestock Judging Contest. There will be a \$10.00 per person entry fee for participation in the Livestock Judging Contest. There will be 3 Question Classes added to the contest. Awards will be given for the top 10 Junior (8-10 yrs.), 10 Intermediate (11-13yrs.) and 10 Senior (14 and up). Tie breakers on Individual scores will be broken by the computerized scoring system predetermined prior to the running of the scores.

25. **GENERATORS OR HEATERS ALLOWED AT THE DISCRETION OF THE SHOW SUPERINTENDENT.**

26. No clipping will be allowed on grounds. This will be strictly enforced.

27. Ear tags shall be checked in each animal as they enter the livestock or holding area. Only animals that are properly validated and that have the correct tag # will be allowed to show. Animals that have lost their tag must have the animal verified by the species validation chairman.

28. No overnight stay in the barns.

29. No Electronic Communication Devices allowed in the arenas.

30. The act of artificially filling animals internally, which would include stomach pumping, drench tubes or any other method per os (by esophagus), is prohibited.

31. **Fans** - No Fans will be permitted in aisles during breeding Beef Show or Junior Market Steer Show. Fans will be limited to one fan per one to three head with one extra fan allowed for each group of one to three head of cows.
Fans behind cattle are NOT allowed.
The superintendent(s) may allow or disallow extra fans due to power or safety concerns or extenuating circumstances but to apply equally to all in show.

32. Any infraction of Rules, that exhibitor's animal will be disqualified.

33. **DOGS ARE NOT ALLOWED ON THE SHOW GROUNDS** because of safety and public health regulations. This rule will be strictly enforced and applies to all exhibitors and their employees as well as Show visitors. Exceptions are granted for dogs that are individually trained to do work or perform tasks for a person with a disability.

34. The BCJLS Board of Directors and/or respective Superintendents have the authority to disqualify animals for rule violations. This includes the conduct of the exhibitor and/or the exhibitor's parent(s)/guardian.

35. The BCJLS Board of Directors and/or respective Superintendents has until the animal leaves the "Exhibitor Only Area", of each class show, to determine if any rule violations, as defined under "Disqualification" of each species, is necessary.

36. The BCJLS Board of Directors and/or respective Superintendents have the authority and right to decide what constitutes acceptable show equipment being used by the exhibitors. Cable halters and pronged chain collars are prohibited for all species.

CLASSES

STEERS

1. VALIDATION - Market steers must be validated in accordance with the Texas Steer Validation Program.
2. WEIGHT - Minimum weight is 900 pounds, there is no maximum weight limit. Milk teeth need not be in place. There will be a 5% tolerance at the scales.
3. CLASSES - All animals will be weighed and broken into classes by weight and breed classification (see General Rule number 15). Breed classes will consist of English, American, and Exotic. Each class will be divided into weight classes.
4. Market Steer Show is a Hair Show in accordance with Ft Worth Stock Show Show rules— it will be a Blow and go show. No clipping of steers shall be allowed on the grounds. Any violation will result in the disqualification of that animal. A determination of violation shall be made by the Market Steer Superintendent. No show day grooming products that alters the appearance of the animal (adhesives, paints, leg builder, etc...) shall be permitted, nor any product that can be wiped off on show day.
5. Any exhibitor may return for showmanship providing they participated in the show that day. A Junior and a Senior Showmanship Champion will be selected for the Steers.
6. Only the exhibitor and their animal will be allowed in the exhibitor/holding area before the show. In the case of multiple entries, the exhibitor will be allowed one assistant in the exhibitor/holding area.

BREEDING BEEF

1. BREEDS - The breeding beef heifers shall be exhibited in four divisions (instead of Breed) grouped as follows:

- American Breed Division - Beef master, Brahman, Brangus, Santa Gertrud's, Simbrah, and any other similar breed.
- British Breed Division - Angus, Hereford, Polled Hereford, and Shorthorn
- European (Exotic) Breed Division - Charolais, Chianina, Gelbvieh, Limousine, Maine Anjou, Simmental, and other similar breeds by origin.
- Commercial Heifers

2. CLASSES-

a. The breeds will be broken into 4 age classes:

- Junior: Less Than 1 Year in Age (on the date of Show)
- Intermediate: Between 1 Year and 18 Months Old
- Senior: Between 19 Months and two years
- Aged: Between 25 and 36 Months old

*Aged Cow Class must provide a Veterinarian's Certificate as proof of pregnancy or have a calf by side.

Grand Champion Heifer
Reserve Grand Champion Heifer

b. Commercial heifers may be shown in the Commercial Heifer Class.
All commercial heifers must still have their baby teeth in place.

Age groups for commercial heifers: SAME AS PUREBRED HEIFERS
Grand Champion Heifer
Reserve Grand Champion Heifer

3. Any breed champion will be allowed to compete for division champion and reserve and then for overall grand champion. The final drive for Grand Champion Heifer will consist of Champion American, Champion British, Champion European and Champion Commercial--provided there are entries in each of these divisions.

4. Breed champions and reserve breed champions will receive a small rosette.

5. Only the exhibitor and his or her animal will be allowed in the holding area before the show. In case of multiple entries the person or persons may be in the area at the same time before going in.

6. Blow and go show. No clipping of heifers shall be allowed on the grounds. Any violation will result in the disqualification of that animal. A determination of violation shall be made by the heifer superintendent. No show day grooming products that alter the appearance of the animal (adhesives, paints, leg builder, etc...) shall be permitted, or any product that can be wiped off on show day.

7. Any exhibitor may return for showmanship providing they participated in the show that day. A Junior and a Senior Showmanship Champion will be selected for the Heifers.
8. Fans: No Fans will be permitted in aisles during breeding Beef Show or Junior Market Steer Show. Fans will be limited to one fan per three head of steers and heifers. Fans behind cattle are not allowed.
9. Validation: To be eligible for the American, British, or European Divisions, heifers must be currently validated with the Texas 4-H and FFA Breeding Heifer Validations Program in the exhibitor's name. Commercial Heifers cannot be validated through the Texas 4-H and FFA Breeding Heifer Program, unless they are certified F1 or like certificated animal. Commercial heifer division is for unregistered females. If there is a question on commercial female certification, the state county heifer validation chairmen and BCJLS heifer superintendent shall make a decision on proper heifer division placement.

MARKET SWINE

1. VALIDATION - All market swine must be validated in accordance with rules in the state/county validation program. All market swine must have either a BCJLS tag or a State Validation tag to show.
2. The validation committee will consist of one AST from each school, the CEA, and four members appointed at large by the CEA. The county-wide validation date will be set on the Saturday nearest the state deadline. Communities, chapters, and 4-H Clubs may schedule validation dates prior to the county-wide validation date.
3. AST's, CEA's and swine leaders from respective 4-H Clubs will be in charge of tagging all hogs validated for the Bexar County Show. It will be necessary that two members of the validation committee verify the validations prior to the deadline for validation. The two committee members verifying the validation must be from another community, school or 4-H Club. Validation cards: All County Validation cards must be turned into the show secretary. Due date will be the same due date as required by the state.
4. WEIGHT - Minimum weight is 165 pounds. Maximum weight is 280 pounds. Hogs of each breed will be divided into three equal weight classes, however, if any breed has more than 90 animals, they will be divided into four weight classes. There will be a ten (10) pound tolerance at the scales.
5. CLASSES - Either barrows or gilts may be shown in the following classes: Berkshire, Duroc, Hampshire, Black OPB (to include Poland China & Spotted Poland China) and a white OPB (to include any of the white breeds including Chester White and Landrace), Yorkshire, Crossbred. Gilts, may be double entered in both market and breeding swine classes. Hogs of each breed will be divided into an equal number of head in each weight class as possible with a minimum of 6 animals per class, and no more than 25 hogs in any weight class.
6. ALL Market Swine will be weighed by breeds, in show order. If someone misses their breeds weigh-in, then they must weigh in the cross division and show in the cross division.
7. DISQUALIFICATION-
 - a. No powder, oil, etc. may be used on the hogs in the show ring.
 - b. A hog with fresh ear notches may not be shown. Any infraction of Rules, that exhibitor's animal will be disqualified
8. GROOMING - No clipping of swine will be permitted at the show grounds.
9. ORDER OF SHOW - Order of show- Berkshire, Black OPB, Durocs, Hampshire, White OPB, Yorkshires and Crosses.
10. Adults may not enter the holding areas, show or sifting ring at any time, unless approved or requested by the Swine Show Superintendent.
11. Exhibitors ONLY shall be allowed to "drive" hogs thru the weigh and sift, and show ring holding pens.

BREEDING SWINE

The breeding swine need to have original registration of ownership by Dec. 1 and original papers to be checked in according to show schedule. Only exception to this Rule is the calf scramble certificate.

1. **BREEDS** - Only purebred Berkshire, Chester White, Duroc, Hampshire, Landrace, Poland China and Spotted Poland China, Yorkshire and other breeds designated by the Board of Directors may be shown.

a. Breeding Swine will show in alphabetical order.

2. **CLASSES** - There will be classes for both boars and gilts of each breed.

Classes will be:

a. July - pigs farrowed in July

b. August - pigs farrowed in August

c. September - pigs farrowed in September

3. **FITTING** - Fitting of breeding swine will be in accordance with major show fitting rules for breeding swine.

4. **DISQUALIFICATIONS** - Breeding hogs with fresh ear notches will not be eligible to show. A fresh ear notch is any notch that has scabs and/or is not completely healed.

MARKET LAMBS

1. VALIDATION - All market lambs must be validated in accordance with rules in the state/county validation program. All animals must have a BCJLS or State validation tag in its ear.
2. WEIGHT - Minimum weight is 90 pounds (80 pounds for Southdowns and Dorpers). There will be a three (3) pound tolerance at weigh-in.
3. CLASSES -
 - a. Both wether and ewe lambs may be shown.
 - b. Breeds with more than 6 entries will be divided into two equal weight groups. Groups with more than 40 lambs in the breed group after weigh-in and classification will be divided into three equal weight groups. If there are more than 60 they will be divided into 4-5 classes.
 - c. All lambs will be classified at the time of weigh-in. Weigh & sift Market lambs by breed (same as show order). See General Rule 15.
 - d. A Finewool may be a Rambouillet, Merino or a cross between these two breeds.
 1. A Finewool Crossbred will be a typical first cross of a Finewool with a Suffolk, Hampshire, Corriedale or Columbia.
 2. Only pure Southdowns will be shown in the Southdown class. Medium Wool lambs will be all other breeds and crosses not eligible in the preceding classes.
 - e. Class must have no less than 6 head per class, if less than 6, they will be moved to cross class.
4. SIFTING - All market lambs will be sifted and classified.
5. DISQUALIFICATION- A lamb may not be shown if the lamb has a fresh-punched, 1/4-inch or larger round, hole in either ear.
6. Show order for lambs: Southdown, Dorper, Finewool, Finewool Cross and Medium Wool.
7. All lambs must be slick sheared to the skin above knee and hock joints, with no more than 1/4 inch wool in length before arrival on the grounds.

MARKET GOAT SHOW

1. Must be a wether goat (castrated billy) or doe (female) goat.
2. Must weigh a minimum of 50 pounds with no maximum weight limit. [A three \(3\) pound tolerance on the minimum weight.](#)
3. Market goats must be body clipped (slick sheared) with no more than 1/2 inch hair before going to show grounds. NO CLIPPING ON GROUNDS.
4. Each student will be allowed three entries.
5. Goats must be shown in collars or halter (including chains).
6. Classes will be broken by weight, with a minimum of 6 goats per class and no more than 25 goats per class. Classes will be divided into five weight divisions (Division I, II, III, IV and V).
7. All goat exhibitors will have a cardboard number that the exhibitor will wear in order to be picked for showmanship. Each exhibitor will wear the same number for all goats entered.
8. Validation - All market lambs must be validated in accordance with rules in the state/county validation program. All animals must have a BCJLS or State validation tag in its ear.
- 9.
10. Exhibitors will be required to have horns tipped blunt on all goats before arrival on the grounds.
11. Unethical Fitting: Unethical fitting includes any attempt to alter the natural appearance, conformation, musculature or weight of an animal by any unnatural means. Injection, drenching or application of any substance per rectum is prohibited.

BOER BREEDING GOAT SHOW

Champion percentage doe will show against champion full blood doe for overall champion.
Reserve percentage doe or reserve full blood doe will compete for reserve overall.

All animals entered in the Boer Breeding Goat Show are required to have registration papers to enter in this show.

POULTRY

1. **CHECK-IN** - All birds must be presented to officials for identification and pen assignment.
2. **SIFT** - A Sifter will be appointed by the BCJLS Poultry Superintendent. Birds must be free of external parasites and disease. The sifter and judge will disregard any wing damage caused by the required wing band. Each bird presented to the sifting committee and entering the show ring must wear the original wing band and the identification number on the band must fall within the series of consecutively numbered birds assigned to that individual or their family at the time of taking procession of bird/birds. Birds losing their wing bands for whatever reason will not be eligible for show.
3. **EXHIBITING** - Only students or designated volunteers may hold birds during judging. Assistance will be provided to the exhibitors, if needed, at the discretion of the superintendent. Parents must stay out of the arena until all judging is complete; any questions or complaints should be directed to the superintendent only.
4. **RELEASE** - Poultry will be released upon completion of the show.

BROILERS

1. Birds will be straight run birds (both pullets and cockerels may be shown) and banded for identification. All birds will be purchased thru Texas A&M University's Poultry Science Department Collage Station.
2. All chicks will be of same hatch and date. Chicks will be hatched so their age will be approximately 40 days of age at the time of the show. All birds must be picked up at a time and place to be determined by BCJLS Poultry Superintendent.
3. Each student must select and exhibit their pen of three birds from within the number range assigned to their family, or where children with different last sir or family names reside as a common address or household for the purpose of this show.
4. Minimum order of 25 birds; a maximum order of 50 birds per exhibitor.
5. Deadline for ordering will be September 10th. School orders will be in lots of 50. All orders will be placed with the superintendent by the deadline.
6. There will be no weight limit.
7. **CLASSES** - There will be a cockerel and a pullet class. The broiler judge will determine the sex of the birds at the time of check in. Only the broiler judge and the BCJLS Superintendent will be allowed in the broiler pen area during the broiler sex identification validation. If a broiler exhibits cockerel characteristics, the pen of 3 will be placed in the cockerel class.

TURKEYS

1. All Turkeys must be ordered by the State Major Show Deadlines through Texas A&M University's Poultry Science Department in accordance with the "The Rules and Procedures" outlined in the letter to all Agricultural Science Teachers and County Extension Agents. The turkeys are to be ordered by the Ag Science Teacher or County Agent. The turkeys will be wing banded at hatching and assigned to the exhibitor. Any turkey without the original wing band/tag will not be permitted to show. Only the wing band/tag numbers originally assigned to individual exhibitors and/or brothers and sisters of a single family will be accepted as the exhibitor show entry.
2. BCJLS Poultry Superintendent will obtain a list from A&M prior to the BCJLS Show listing exhibitor name, purchased amount of Turkeys with assigned wing band numbers.
3. All Turkeys must be owned and fed by the exhibitor from the order pickup date.
4. There will be no weight limit.
5. CLASSES - There will be a Hen and Tom class.

-

RABBITS

1. SPECIAL RULES - Rabbit classes will be governed by the rules of the ARBA's, current Standard of Perfection issue. No crossbred or mixed breed rabbits will be allowed in the show.
2. WEIGHTS - Minimum weight on market rabbits is 3.5 pounds each, maximum weight is 5.5 pounds each. No tolerance.
3. TATTOOS - All rabbits will be permanently earmarked in the left ear, using two or more separate numbers or a numbers\letters combination. No two market rabbits from the same exhibitor shall have the same earmarks.
4. SUBSTITUTIONS - No substitutions or changes of ear tattoo or age groups on entries will be allowed after the judging begins.
5. SIFT - Sifted rabbits will be clearly marked with a paint stick and may not be presented again for sift.
6. Validation dates- All market rabbits must be validated. Rabbits will be validated per family. Only eligible exhibitors in that family may exhibit these animals. Exhibitor may validate as many rabbits as they wish. Meat Pen Validation dates will be scheduled by the Rabbit Superintendent the week the rabbits are to turn 6 weeks old. The Locations, Dates, and Times will be posted on the website.
7. CLASSES - Classes for rabbits will be as follows:

MEAT PENS

- a. Each pen is to consist of three rabbits of not less than 3.5 pounds and not over 5.5 pounds each.
- b. Entries may not be over 70 days of age.
- c. All entries must have been raised to fryer size by the exhibitor (see ownership period in item 16 of the General Rules).

BREEDING RABBITS

There will be classes for both bucks and does in the following groups:

1. Classes for all breeds under a 9 pound minimum senior ideal weight are:
 - a. Junior - under 6 months of age.
 - b. Senior - 6 months of age and over.

2. Classes for all breeds having a 9 pound minimum senior ideal weight are:
 - a. Junior - under 6 months of age.
 - b. Intermediates - 6 months of age and under 8 months of age.
 - c. Senior - 8 months of age and over.

3. Rabbit classes to be governed by rules of the current ARBA Standard of Perfection.

PREMIUM AUCTION RULES

1. NUMBER TO SELL - TBD. Number of placing in each / all classes tbd

All animals placing in show percentage will receive their placing ribbon before leaving the show ring. Any exhibitor leaving the show ring without receiving their placing ribbon will be disqualified from sale.

2. ORDER OF SALE - Order of sale will be determined by the Show [Officials](#) and Show Works Computer Program.
3. ELIGIBILITY - Only those students receiving market show ribbons will be eligible for the sale.
4. NOTIFICATION OF INTENT TO SELL -
 - a. One hour after the completion of the judging of the last market class, a meeting to make the auction list will be held with the superintendents and at least one representative of each FFA chapter and each 4-H club present. It is the responsibility of the chapters and the clubs to make certain that their club or chapter is represented. The club or chapter representative is responsible for informing the Show as to which entry is to sell in the event that an exhibitor from their club or chapter has more than one entry to qualify. It is the responsibility of the exhibitor to inform their representative of their intentions prior to the meeting. In the event that no club or chapter representative is present or does not inform the Show, the first entry to be announced as eligible to sell will be the entry listed on the auction list. Once the entry is on the auction list, it may not be removed from the sale.
 - b. If an exhibitor removes an entry from the auction sale after the auction list has

been printed, he or she will be barred from showing the following year. The show secretary will place an exhibitor on the sale list using the highest placed animal to determine sale order. If the exhibitor has two 1st place animals the animal that showed first will be entered on the sales list. It is the responsibility of the FFA chapter or 4-H club to check the sales order list. If the club manager or AST fails to inform the show secretary of which animal to sell, the highest placing animal will be sold.

5. LIMIT - Each exhibitor will be eligible to sell only one (1) entry. (Live or Silent Auction)
6. METHOD OF SALE - All entries will sell by the lot.
7. EXHIBITING THE LOT FOR SALE -
 - a. Each exhibitor should be present for the sale of his or her lot. Exhibitors must gain approval from their division show superintendent, in advance, of the reason for not presenting his or her own lot. If Exhibitor or Substitute is not present, the lot will not sell.
 - b. Exhibitors must check in with the Line-up Superintendent 50 lots in advance of their sale lot. If Exhibitor or Substitute is not present the lot will not sell.
 - c. Parents are not allowed in the Sale Ring. No more than 2 students will be allowed in the Sale Ring per lot number. Exhibitors can only bring into the sale ring a 8X10 framed picture, ribbons from the current BCJLS, and lot number. NO OTHER ITEMS WILL BE ALLOWED. No presents to buyers, banners, balloons, signs, etc., are allowed in the sale ring.
 - d. Each exhibitor participating in the Sale of Champions, including eligible arts and crafts, must have their photo taken and purchase a photo from the official show photographer. Said photo maybe displayed at the sale of the lot.
8. Grand Champion and Reserve Grand Champions in each division of the Creative Arts Competition have the opportunity to sell their craft/food item (recipe) in the Premium Auction as placed in sale order by ShoWorks.
9. COMMISSION - A sales commission of seven percent (7%) of sale value will be charged on all sale lots, pledges and add ons.
10. PAYMENT -

*REPLACEMENT CHECKS WILL INCUR A PROCESS FEE

 - a. Thank You note information for Exhibitors: The Exhibitor's Thank you letter(s) to his or her buyer(s) must be submitted to Board of Director representative on the 3rd Tuesday of February from 6:30 PM till 8:00 PM at the BCJLS office at 7701 FM 1346, and must include ALL contributors on provided thank you list including belt buckle sponsors. Each letter must be ready to be mailed with an addressed, stamped and sealed envelope.

Note: Any exhibitor awarded a belt buckle is required to send a thank you letter to his/her belt buckle sponsor. These letters are to be turned in at letter night, the 3rd Tuesday in February. In the event the exhibitor's letter(s) is not provided on the 3rd Tuesday in February a 10% penalty fee will be deducted from the exhibitor's

check. In the event a thank you letter for a belt buckle is not sent, the 10% penalty fee will apply. In the event the exhibitor's letters are not received by March 1, the sale of the animal will be voided.

- b. To process exhibitor payments more timely, if any buyer fails to pay their bill by April 1, the exhibitor will not be paid the outstanding amount. The exhibit will be paid moneys collected, and be provided a list of buyers and amount outstanding unless buyer has indicated that the bid was not authorized. If buyer provides partial payment, the proceeds will be distributed proportionally to exhibitors.
 - c. Any unauthorized auction bid amounts will not be paid to exhibitor.
11. NO 4-H or FFA EXHIBITOR WILL BE ALLOWED ON THE AUCTION FLOOR.

1. **Entry Fee:** The entry fee for each project entered is \$20.00. Entries must be included on the official group summary sheet along with any other juniorentries.
2. **Eligible Entries:** Entries are limited to FFA and 4-H members.
3. **Projects:** Projects must have been constructed by FFA & 4-H either as a part of their agricultural mechanics instruction in agricultural science or as part of their supervised work experience program. Projects must be designed and constructed under the direct supervision and guidance of the CEA/AST.
4. **Group Entries:** Group entries must be made in the name of the FFA Chapter or 4H Club. Group entries must include only the names of the exhibitors who participated in planning and construction of the project. Group entries are considered to be those that are constructed by two or more students.
5. **Individual/Group:** Projects may have been individually or group constructed and may be individually or chapter/club owned.
6. **Number of Entries:** No individual or group may enter more than 3 projects. No individual or group may enter more than one project per class. This does not limit the number of projects a chapter or club may enter.
7. **Exhibit Space:** Projects will be grouped and displayed by classes Placement of the projects will be at the discretion of stock show officials. Display space under shelter is not guaranteed.
8. **Construction Date:** A project may be exhibited only one time at the Bexar County Stock Show and must have been constructed within one calendar year of the exhibition date.
9. **Types of Projects:** Only those projects that fit into the stated classes will be accepted. Final project classification will be at the discretion of show officials.
10. **Vehicles:** No trucks, non-entered tractors, or other vehicles (including non-entered trailers) are allowed in the exhibit area as part of the display.
11. **Project Completeness:** All projects should be complete including finish. Any item, necessary for use of the project, must be a part of it (example: hinges and latches on gates and panels).
12. **Project Presentation:** Items to be considered are:
 - a. Neatness of project - Clean and free of dust and debris.
 - b. Neatness of surroundings - Includes floor under and around the project.
 - c. Documentation - Presented in a manner that judges and the public can view it.

- d. Signs - Must be appropriate, easy to read, and not too large as to take unusual space.
 - e. Exhibitor Card - Attached to the front center of the project. It is recommended to attach the card with Carton Sealing Clear Plastic Film Tape (duct, electrician, masking orscotch tape are not appropriate). Should be displayed neatly and in a location that is highly visible.
 - f. Safety - All safety procedures must be adhered to when displaying projects.
 - g. Clutter - Exhibitors should confine paraphernalia, chairs, show boxes, cleaning supplies, brooms, and wiping rags to their assigned display area.
 - h. Painting/Scratches - No paint is allowed in the barn. Judges will be instructed to make allowances for scratches or damage due to transportation.
13. Exhibitors Presentation: Items to be considered are:
- a. Attire - Exhibitors should be dressed appropriately and be with their project when it is judged.
 - b. Sportsmanship - Exhibitors should be courteous and helpful to those viewing their project, including those exhibiting next to them. Exhibitors should not interfere with or shield those who are exhibiting next to them.
 - c. Knowledge - Exhibitors should be available to answer questions when their project is being judged. Knowledge of the project will be evaluated at this time. Exhibitors should be well informed of the project they are representing, but should not be boisterous or argumentative.

Note: An approximate judging schedule for each class will be posted, but it is the exhibitor's responsibility to be present if the schedule should be changed. Changes will be announced or posted in advance when possible. At least one chapter/club exhibitor should be available to answer questions from the public or show officials including showmanship at all times.
 - d. Exhibit Aids - Exhibitors should provide any equipment that may be necessary to judge their project (flashlights, mat or creeper for judging projects that the judge would need to get underneath). Exhibitors may be requested to hold measuring tape and assist the judge in making measurements on project.
14. Documentation: An original working plan or drawing, photographs showing stages of construction and a bill of materials are required with each project. Additional documentation may be required for plans of vehicles that are used on public highways (rule16) ASAE standards must be met on three point hitch and PTO Operated equipment (rule 17). The following web page: <http://swt.edu/~ls04/shell.html> will contain links to ASAE and DOT Standards and Codes. The web page may also be accessed from the IMS web page.
- a. Working Drawing - Should include an original multi-view orthographic projection drawn to a given scale with proper lettering and dimensioning. Dimensioning shown on drawing should be specific and complete enough for it to be apparent that drawing was used to plan and construct project Judges will spot check

dimensions on projects to see if they comply with drawings. Drawing may be a CAD (Computer Aided Design). Pictorials, isometric oblique, or perspective may be included.

- b. Bill of Materials: Must include a list or a description of material, including quantity, size, and cost. Other Information such as date of purchase, vendors name and/or Purchase Order Number, etc. may be included.
- c. Photographs - Showing work in progress should depict proper safety procedures including clothing, eye and face shields, etc. Photographs should be sequenced in the order of constructing the project. Any project not having documentation will be disqualified. Any project not having all three documents will be placed down a ribbon.

15. Safety:

Display: Appropriate and safe display stands are to be provided for gates, panels, and other projects that need support. Sharp edges and points, such as found on self feeder roofs, bale movers, etc. are to be padded and/or covered as necessary to prevent possible injury.

Transportation: All trailers and other equipment that will be operated and/or transported on public roads must be equipped with safety equipment specified in Title 7, Vehicles and Traffic Transportation Code of the Texas Statutes. Specific chapters regarding Width (621.201), Lights & Reflectors (547.322, 547.323, 547.324, 547.325, and 547.332), Brakes (547.401 and 547.402), Length (621.204) and Inspection (548.052) must be adhered to. Agriculture Exceptions - No Agriculture Exemptions for the following:

- a. All tongue trailers must have approved safety chains. Information regarding approved Materials and attachment method may be obtained via web page.
- b. All gooseneck trailers must have approved safety chains and brake-away equipment.
- c. Any trailer that is over wide (102 inches) must have a signed permit. Trailers widths will be measured from metal to metal. Tire will not be considered in width except when tire tread extends beyond the fender. Hubs/caps must not extend beyond tire bulge/cheek. Any trailer that does not meet these requirements will be disqualified.

16. ASAE: All three-point hitch and/or PTO operated equipment must meet the latest ASAE (The society for engineering in agricultural, food, and biological systems) standards. Power take-off equipment must meet ASAE standard S203, Rear Power Take-Off for Agricultural Equipment. All semi-mounted or mounted equipment must meet ASAE standard S217, Three-Point Free Link Attachment for Hitching Implements to Agricultural Wheel Tractors.

17. Signs: All projects are to be identified with standard club exhibitor cards. Additional signs, banners, etc. are encouraged, but are subject to approval. No "For Sale" signs are permitted.

18. Loss or Damage: Every precaution will be taken to protect the projects, however, neither the Bexar Stock Show nor the officials of this division will be responsible for any loss or damage to projects.

19. Projects with Engines: No more than two gallons of fuel in any fuel tank is allowed. The fuel tank cap is to be in place and sealed with tape and the battery, if equipped, is to be disconnected. Tractors in the restoration division may have up to five gallons of fuel in the fuel tank.
20. Projects Needing Offloading Assistance: Projects that must be hoisted from the top-side are to be fitted with lifting eyes at balance points that will accommodate one inch shackles. Participants or Charter/Club must provide their own safe offloading equipment. Projects that, in the opinion of show officials, cannot be safely offloaded with their own equipment will be shown at an alternate site.
21. Types of awards presented will be based on donations received for the show. Thank you letters must be sent to donors and/or contributor's, along with copies sent to AG Mechanic Superintendent and local Chapter /Club prior to awards being released.
22. All Division Champions and Reserve Champions from each class will compete for Best of Show Ag Mechanics and Reserve Best of show AG Mechanics.
